#### **Course 1** Therapy to Enhance the Caregiver's Caregiving Presented by: Edward H. Tiller Ph.D. (Williamsburg Centre for Therapy)

As we age our physical and cognitive functioning may become significantly impaired (Dementia) resulting in needing caregiving by others. Frequently the caregiver is one's spouse or adult daughter/son. Caregiving is s very challenging responsibility. It typically requires years of committed effort. Caregivers often feel, and find themselves, very alone in their daily 24/7 commitment. It can be physically, emotionally and intellectually exhausting.

#### **Objectives:**

1) Dementia is a general term used to describe the symptoms of mental and physical decline that characterize Alzheimer's and other neurological disorders. Middle stage Alzheimer's is the longest stage and it can last for many years. Name three symptoms of this stage. 2) Besides loneliness and mild depression, what other negative emotion frequently accompanies caregiving?

Dr Tiller is the immediate Past-President of VACP. He has been in full time private practice at Williamsburg Centre For Therapy since 1990. After receiving his PhD at the University of Tennessee in 1970, he accepted a position in the Psychology Department at the University of Richmond. His treatment focus then was with children and adolescents. Over the years he shifted to working with adults including those 65+. A significant portion of his patients seek therapy because of dealing with grief, guilt and/or trauma. Many of these are caregivers.

## Course 2

#### *Overview of Trauma Focused Cognitive Behavioral Therapy (Intro)* Presented by: Alicia Meyer, Ph.D. (Executive Director, Alicia's Place)

This is an overview of TF-CBT, which is a trauma informed treatment for children between the ages of 3-18.

#### <u>Objectives:</u>

1) Identify at least 3 ways that trauma impacts child development. 2) Describe 2-3 strategies/techniques to accomplish the goals of the Stabilization phase. 3) Describe 2-3 methods/media to accomplish the Trauma Narrative.

Alicia Meyer, Ph.D. is a licensed clinical psychologist who has devoted the last decade of her career to the health and well-being of children, families, and trauma survivors. She was the Mental Health Director of the Child Abuse Program at the Children's Hospital of the King's Daughters (CHKD) and completed her studies to become a National Trainer in Trauma Focused – Cognitive Behavioral Therapy (TF-CBT). She is also a certified therapist and Global trainer in Parent-Child Interaction Therapy (PCIT). Simultaneously, Dr. Meyer founded Alicia's Place, a non-profit agency that utilizes a cognitive-behavioral, multi-systemic, empirically-validated approach to the psychological assessment and treatment of trauma survivors. Dr. Meyer is also the president of the Virginia Academy of Clinical Psychologists.

## **Course 3**

#### The Complex and Differing roles of Trauma in Borderline Personality Disorder and Bipolar Disorder (Intermediate)

### Presented by: William Moncure, M.A., (Psy.D. Candidate, JMU)

What role does trauma play in the etiology and pathogenesis of Borderline Personality Disorder and Bipolar Disorder? Although Borderline Personality Disorder is more closely associated with a history of trauma in the literature, many individuals with Bipolar Disorder also report a trauma history. This presentation will discuss the overall role of trauma in Borderline Personality Disorder and Bipolar Disorder, and how knowledge of trauma history and presentation may be useful in differential diagnosis.

### **Objectives:**

1) Helping clinicians in practice understand the role of trauma in both Bipolar Disorder and Borderline Personality Disorder. 2) Describing how patient trauma history may be useful in differential diagnosis. 3) Identifying how using a trauma-informed approach can impact the trajectory of these the disorders over time.

My clinical interests involve working with individuals with severe mental illnesses, addictions, and mood disorders. I have worked in inpatient settings with adolescent, adult, and geriatic populations, as well as in a rehabilitation center for addiction treatment, intensive outpatient, and outpatient settings. I completed a Master's degree in Mental Health Counseling, a Graduate Certificate in Addiction Counseling, and I am currently completing my Doctorate in Clinical Psychology at James Madison University. My dissertation work focuses on differential diagnosis between personality disorders and mood disorders. I have previously given presentations on ethics in the use of restraints in psychiatric hospitals, group therapy for addictions, and differential diagnosis. In the future I hope to continue my dissertation research, and eventually transition into outpatient practice.







## Course 4

#### *Board of Psychology Conversation Hour* Presented by: Aliya Chapman, Ph.D. (Board Vice-Chair)

Members and staff of the Virginia Board of Psychology will provide an update on relevant and timely issues under consideration by the Board, including Masters-level licensure and licensing exams. Panelists will answer questions on topics under their purview from the audience.

#### **Objectives:**

1) Identify two issues currently under discussion in the Virginia Board of Psychology. 2) Identify how to find out specific and detailed information online about upcoming changes to psychology licensure.

Dr. Chapman is a Licensed Clinical Psychologist and a graduate of George Mason University in Fairfax, VA. She has served on the Virginia Board of Psychology since mid-2020 in addition to her private practice work in Blacksburg, VA. Dr. Chapman also serves the Virginia Academy of Clinical Psychologists (VACP) as the current Newsletter Co-Editor.

## **Course 5**

From Shame to Acceptance: Helping Patience Manage Internalized Weight Stigma in Clinical Practice Presented by: Lauren Ehrlich, PhD; University of Virginia School of Medicine

Over 40% of the adult U.S. population is considered overweight or obese based on BMI estimates (Hales et al., 2020). Much attention is given to obesity treatment and weight management. Weight stigma refers to the social devaluation of an individual due to their excess body weight, which leads to negative attitudes, stereotypes, and discrimination. This presentation will highlight acceptance-based interventions and their evidence base for reducing the impact of internalized weight stigma.

#### **Objectives:**

1) Participants will gain an understanding of the definitions of internalized weight stigma and its impact on wellbeing and functioning. 2) Participants will learn strategies to help patients manage weight and body image concerns. 3) Participants will be better able to identify and combat their own weight bias.

Dr. Lauren Ehrlich is an assistant professor of Psychiatry & Neurobehavioral Sciences at the University of Virginia School of Medicine, where she completed her postdoctoral fellowship in 2021. She recently returned to the University of Virginia after spending two years at Dartmouth Health in Lebanon, NH. She completed her undergraduate work at the University of Notre Dame and earned her graduate degree at the University at Albany, SUNY in upstate New York. Dr. Ehrlich is a clinical health psychologist who specializes in helping patients make health behavior changes, particularly related to their eating. She is passionate about helping patients heal their relationships with food and their bodies.

## Courses 6 - 8

Sequence XII: Navigating Challenging Conversations: Ethics and Risk Management Presented by: Marc A. Martinez, PhD, The Trust



For over two decades, The Trust has worked to educate and support psychologists in improving their ethics and risk management skills and strategies by providing live workshops, webinars, risk management consultation, and expanding resources. This 12th workshop in our Sequence series continues to emphasize applied, integrated and strategic methods to help you stay grounded in ethical principles and practices and to protect yourself from adverse disciplinary and legal actions.

The Trust Risk Management Consultants have culled subject matter from some 110,000 consultations provided to date to focus this workshop on problems practitioners often encounter. The overarching theme of Workshop 12 is on the ethics and risk management of navigating various types of challenging conversations that arise in professional practice. Specifically, topics will include: the

possibly impaired or unethical colleague; race and microaggressions; record keeping and the Information Blocking Rule; mandated child abuse reporting; multiple relationships and conflicts of interest in collateral versus conjoint services; managing risks of cross-jurisdictional telepsychology; and the ethics and risk management of responding to patients/clients who engaging in stalking, threatening, or harassing behaviors.

#### **Objectives:**

1) Describe at least five basic principles of ethics and risk management, as applied to several specific clinical situations that frequently arise in professional practice; 2) Identify three risk factors and warning signs of distress factors and warning signs of

distress/impairment in ourselves and our colleagues, and list three primary interventions for managing professional distress/impairment, and delineate two factors to consider when preparing for a conversation with a potentially impaired colleague and for deciding the appropriateness of a formal or informal ethical resolution; 3) Describe two methods for effectively engaging in challenging conversations regarding race and ethnicity with colleagues, supervisors/supervisees, and patients/clients; 4) Define the Information Blocking Rule and explain two strategies for ethically managing risk related to this rule; 5) Identify three types of immunity provisions that protect psychologists who make mandated child abuse reports; and list three steps psychologists can take to minimize their risk in these situations; 6) Apply at least two risk management strategies for decreasing risks when involving collaterals in treatment and/or providing conjoint psychological services; 7) List four broad categories of factors to consider when determining whether to provide cross-jurisdictional telepsychological services; 8) Discuss four strategies for ethically and safely managing patients/clients who exhibit stalking, threatening, or harassing behaviors.

Dr. Marc A. Martinez received his B.A. from Cornell University and his M.S. and Ph.D. from the University of Georgia. In 2011, Dr. Martinez became board certified by the American Board of Professional Psychology in Forensic Psychology. Dr. Martinez is currently a licensed psychologist in Indiana as a Health Service Provider in Psychology, Ohio, and New York. He also has authority to Practice Interjurisdictional Telepsychology (APIT) and Temporary Authorization to Practice (TAP) under PSYPACT.

Dr. Martinez has been an ethics and risk management consultant to mental health professionals for The Trust's professional liability insurance program since 2020. Dr. Martinez founded his private practice, Clinical and Forensic Psychology Services, in 2012 through which he provides a variety of forensic and clinical services, including evaluations and consultations related to competency to stand trial, criminal responsibility/insanity defense, sexual recidivism risk (including civil commitment of individuals who commit sexual offenses), violence

recidivism risk, and disability determinations. Prior to establishing his private practice, Dr. Martinez worked as the lead forensic psychologist for a secured forensic unit at a state psychiatric hospital in Georgia and as an independent examiner for New York State's Bureau of Sex Offender Evaluation and Treatment.
